Stud Book Entry, Inspection, and Licensing Fees (add GST/HST)

All entered mares and stallions are to be DNA tested (<u>OR</u> submit DNA test report)	\$60
Mare Entry (without inspection for approved mares from other registries)	\$90 one time
Mare Entry and Inspection (2 to 5 years of age)	\$120 one time
Mare Entry and Inspection (6 years of age or higher)	\$150 one time

Mare Entry (other non-inspected mares)	\$60 annually

Stallion Entry (without inspection for approved stallions from other registries)	\$150 one time

Stallion Licensing and entry (2 year old on successful Licensing)	\$250 for 2 years
Stallion Inspection (3 years and older) including Licensing and entry	\$500 for 2 years
Stallion License extension	\$250 for 1 year
