BREEDING DIVISION-MATURE HORSE (Ribbons to 5th in each class except championships)

All mares entered for inspection are entered into classes 1-4 without further fees

- 2. Mare, 4-6 years , with or without foal. Mare only judged \$40
- 3. Mares 7+, with or without foal. Mare only judged \$40

YOUNG HORSE DIVISION (Ribbons to 5th in each class except championships)

Horses will be presented in hand on the triangle. Foals may be loose at the mare's side. Judges may choose to see horses presented loose for canter as well if sufficient handlers are present. This will be the judge's choice and will apply to all horses in the class if so decided.

PRIZES

Funds in the CWHBA Alberta Chapter Foal Futurity Fund and 50% of the entry fee will be awarded 1st through 5th place for the Foal Futurity.

The Garry Bresee Memorial Trophy will be decided by points earned on placings and championships.

Mare Inspection Information

1. To enter your mare for inspection: Please indicate on the show entry form that you wish to enter the inspection with the class number for the appropriate age group. Then fill out the Application for Stud Book Entry and Evaluation form attached here. **Inspection Application for Pedigree Approval & Stud Book Entry | Fillable** It may be submitted with payment to the national office at any time but no later than Sept 11/22 to encourage early submission. The application for this inspection will be eligible for a full refund if attendance becomes not possible until Sept11/22.
2. You must be a full member of CWHBA to have your mare inspected. The membership fee is \$85 payable to the CWHBA office.
3. If we are running only one ring, then mares will be shown on the triangle only once and that score will be carried forward where applicable to additional classes and championships. If we are running two rings, then the mares entered in both the inspection and the show will be presented on the triangle twice. Please have sufficient handlers as all mares in one group will be walked together. Mare Inspections and Classes will be run in order of age group.
4. Mares entered in the inspection will be automatically entered in the appropriate age show class at no additional fee. No prizes are awarded for the inspection. Ribbons to 5th place for the mare show.
5. DNA must be collected on each mare and submitted to the CWHBA office along with the fee for the DNA testing if not on file.

CWHBA Mare Inspections:



The inspection evaluations are an important tool in the CWHBA efforts to meet their breeding aim to produce a well-bred Warmblood horse suitable for Olympic and related Equestrian sports. The Application for Stud Book Entry and Evaluation are on the tri-part form. You must be a current Annual Member of CWHBA.

The following inspection criteria apply:

1. Breed & Sex Type
 2. Quality of Conformation *
 3. Correctness of Gaits
 4. Swing & Elasticity of Gaits
 5. Walk
 6. General Impression & Development
- *Conformation (#2) – is calculated as an average of sub-scores for head, neck, saddle position, frame, forelegs & hindlegs.
The average, will be carried over to the main category*

Scoring System:

Each category is judged on a point system out of 10:

10 excellent	5 sufficient
9 very good	4 insufficient
8 good	3 rather bad
7 fairly good	2 bad
6 satisfactory	1 very bad

For mares: - the overall assessment is reached by adding all the categories (1-6) and dividing by 6. Mares will receive a number score, and will also be linear scored.

CWHBA Inspection Presentation

1. DRESS CODE:

Handlers and assistants are to wear dark green tops and black pants. Gloves are recommended. Shoes appropriate for running. Helmets are recommended for all handlers, particularly those handling foals and young horses.

2. TACK:

Horses to be shown in snaffle bridle with or without cavesson; regular or flash cavesson acceptable. A split or single chain may be used in addition to, or instead of reins.

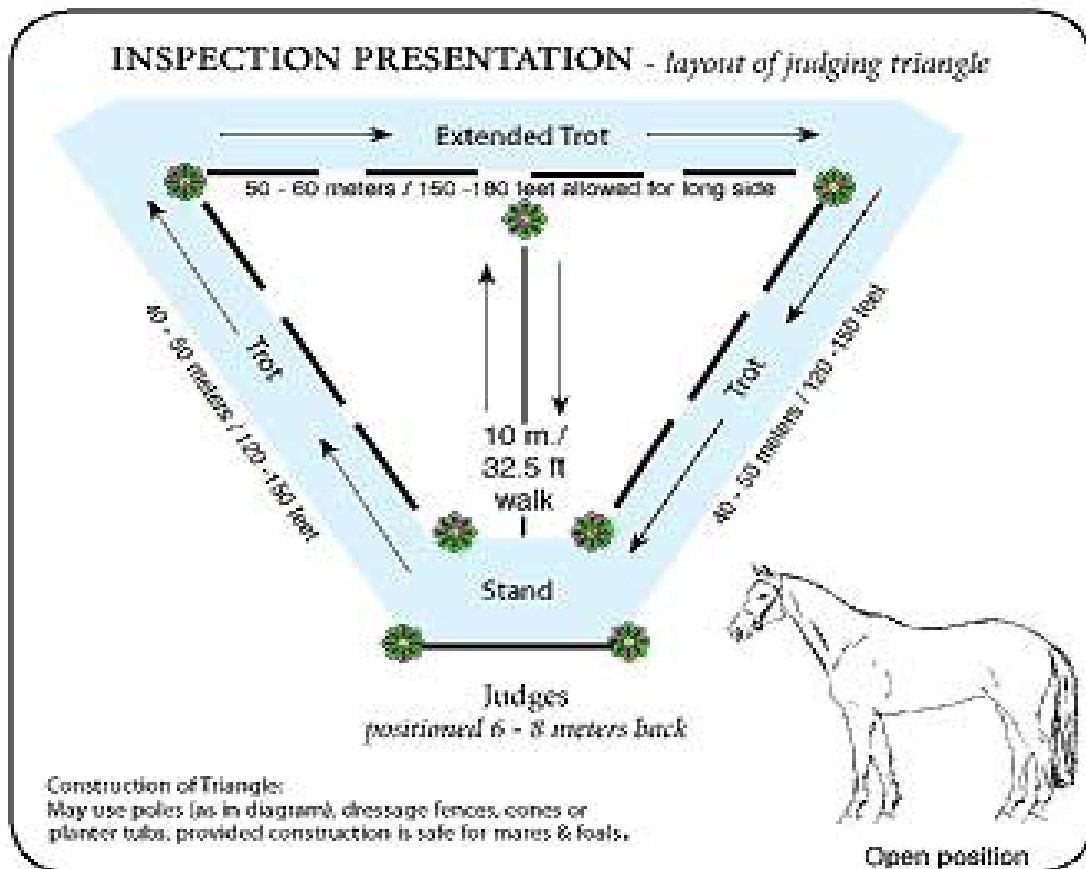
3. BRAIDING:

Horses should be braided whenever possible. It is a courtesy to the inspectors and the spectators to have the horse presented in show conditions.

4. SHOWING ON THE TRIANGLE: INDIVIDUAL

The inspection will always take place on a triangular course. The first step is the individual inspection. The handler places the horse at a distance of about 4 to 5 meters in front of the judges. (The left side of your horse should be facing the judges.) Here the so-called open position is obligatory.

The judges then score the individual marks for conformation. The handler will then be asked to walk straight away for 10 meters, turn around the marker to the right and return to the original starting position. The horse should walk freely forward and straight on a reasonably loose rein.



5. PRESENTATION IN TROT

Afterwards the handler is asked to trot one lap with the horse in clockwise direction. The judges stay at the same place, and with the triangular form of the course they are able to first inspect the horse from behind, then its action deployment from the side, and finally its correctness from the front. For that reason, however, it is necessary to follow exactly the triangular form of the course.

At the trot (extended trot) the horse should be given the chance to move as freely as possible. With regard to very actively moving the horse the handler should be someone who is able to move well enough him/herself to show the movement. When trotting your horse you take both the reins in your right hand.

It is advisable that someone with a whip is driving your horse from behind as you are expected to show the horse without a riding whip. After the trotting lap the horse is turned once again and shown to the judges from the right side standing. Judges may allow a second trot to see movement.

6. PRESENTATION OF WALK - GROUP

When a number of horses have been judged at the trot they are assembled in a large circle and judged at a walk. The walk should also be shown as relaxed and freely as possible. Where sufficient numbers are presented, mares will be divided into groups by age.

Some Points to consider

With more horses than ever before presented for inspection, sometimes the results do not meet the expectations of owners or spectators. The following are points taken from the article 'Inspection in Perspective' published in the 1997 Handbook. Reprints can be made available.

- The prettiest is not always the best: Beauty draws us to horses but performance is our true goal. A conformation asset may be nullified by a poor walk or incorrect gaits. Conversely, a confirmation weakness may be balanced by outstanding gait and correct movement. Because these details can be missed when viewed from the sidelines, spectators may find it hard to understand the judges' placings. There fore at all inspections the commission's comments are made in public to provide a learning opportunity and ensure that the commission can explain what they have done.
- Turnout is important: It is not fair to the horse when the commission is asked to overlook lack of braids, grooming or lack of condition to make an honest appraisal. Inspectors see the horse for ten minutes
- Please ensure that horses have had some exposure to trotting in hand prior to show/inspection day.
- Free lunge is used to evaluate trot and canter for the young horses. Please expose them to free lunging before show day, and bring a quick release lead shank or reins.

It should be the best ten minutes of that horse's life.

- Present early for best results: It is best to show your mare at age three or four before she has had a foal or injury which could lower her score.
- Showing in-hand requires a skilled handler: Please ask for assistance or instruction from someone with more experience or perhaps someone younger and faster if you are unsure that you can present your horse well.
- The most important judge is you! No commission is perfect. No event goes entirely as planned. Observe and evaluate where your breeding program is going, compared to others. In the end, each of us makes our own breeding decisions for our broodmares. Inspections are an important tool in our efforts to produce that perfect horse.
